# 1- LIMITED ONE YEAR WARRANTY ON ALL PRESTIGE CON-DENSING BOILER COMPONENT PARTS.

# **Limited Ten Year Warranty**

Triangle Tube/Phase III Co. Inc. Inc further warrants, to the original user of the above Prestige EXCELLENCE Condensing Boiler, that the stainless steel heat exchanger, shall be free of leaks during normal use and service for a period of ten (10) years from the date of purchase. In the event that a leak should develop and occur within this limited warranty period due to defective material or workmanship, we will replace the heat exchanger, or repair same at our sole option under the conditions explained in paragraph 4, hereof.
